### Terms & Conditions:

- It is understood this studio is the exclusive official photographer retained to perform the photographic services requested on this contract. It is hereby agreed that NO other professional (paid) photographer (or news photographers) will be invited or allowed to shoot pictures at this event.
- No part of any order will be delivered until the balance is paid in full.
- The studio reserves the right to use digital files &/or reproductions for or other purposes. Digital files & previews remain the exclusive property of this studio.
- In the event of a postponement or cancellation of the contract by the Client, all payments paid are not refundable.
- The studio takes utmost care with respect to the exposure, development, & delivery of photographs which will take between 6-8 weeks from the event date. However, in the event the studio fails to comply with the terms of the contract, due to any event or act outside the control of the studio, the studio's liability is limited to refund of the retainer.
- Editing & Retouching: Proof images (including online proofs, digital negatives & images on CDs, discs, flash drives) may be edited by Photographer for color correction, contrast, & tone but there will be no retouching or advanced correction applied to the proof images. Images used for albums, custom books, custom prints & enlargements may go through an additional process of editing & correction techniques, subject to Photographer's unilateral discretion & artistic control. Any additional editing & retouching requested by Clients will require additional fees, with the fees set by Photographer based on the extent of the requested changes. Clients will be provided with an estimate prior to Photographer commencing the performance of additional editing. Clients shall not make any adjustments to the images themselves, including but not limited to, changing colors/tones, adding textures &/or changing the image from color to black & white.
- For any albums that are included in this contract stated above or ordered separately, the Client will be provided a proof for approval and will be allowed up to six (6) revisions at no additional cost. Any additional revisions will incur a fee that will be responsible by the Client. For any albums or prints that are included in this contract stated above, the Client has 365 days from the date of event to contact the Photographer to place the order otherwise it will be forfeited.
- It is agreed that client assumes all risk for loss of images caused by amateur photographers, videographers, or moving spotlights.
- Meals for the Photographers: Activities happen quickly once they begin, & there are few if any opportunities for even short breaks, much less full meals. Shooting a long event can be exhausting & we need to stay hydrated & keep our energy up but will not have time to leave the events & get our own food or drinks. Because of this, for any event lasting five (5) or more hours, we require that you provide our meals at the same time as yours, & at a location that is within sight of you & your guests so we don't miss anything important.
- NOTICE OF COPYRIGHT: It is ILLEGAL to copy or reproduce these photographs elsewhere without Photographer's permission, & violators of this Federal Law will be subject to its civil & criminal penalties.
